Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

Tuition/Fee Policy Summer 2022

Policy:

Summer Registration Fees are \$15.00 per student and are **non-refundable**.

Registration Fees along with a minimum of one-week tuition for camp/intensive, per student, are **due at the time of registration**.

Additional registered weeks of camp/intensive will automatically be charged to your account on the Friday prior to the week the camp/intensive begins. For multiple registered weeks of camp/intensive a credit card must be kept on file.

Non-payment of camp/intensive tuition will result in your child being withdrawn from the program.

No reimbursements or credits will be allowed for any missed days of camp/intensive. Exceptions will be made only for serious injury, illness, or family emergencies. **Proof is required.**

Withdrawal from any registered week of camp/intensive **is required in writing at least one week in advance.** Tuition will be considered earned and due if a withdrawal notice is given **less than one week prior to the start of registered week of camp/intensive.**
