Tuition Payment Plans: Plan I - Tuition is due in 2 installments - At registration and

January 1, 2024

Plan II - Tuition is due in 10 installments - At registration and on the 1st of the month from September 2023 - May 2024

Open Classes: Drop in 1 hour classes are \$20.00 per class or \$200.00 for 10 classes,

1.25- 2 hour classes are \$25.00 per class or \$220.00 for 10 classes.

Private Classes: Director's Fees - ½ hour -\$50.00 per lesson/ 1 hour -\$100.00 per

lesson.

Instructor's Fees - ½ hour- \$45.00 per lesson/ 1 hour -\$90.00 per

lesson.

Policy:

- -Registration Fees are \$45.00 for the first student and \$20.00 for the second and third student. The maximum family registration fee is \$85.00. Registration Fees are **non-refundable**.
- -For families with multiple students attending FSDE, a family discount of 10% will be applied to each additional student's tuition.
- -Students registered at FSDE are considered registered for the entire season and payments are expected to be paid for the season. If a student must withdraw for any reason other than serious injury or illness, a **30-day** written notification is required and **one month of tuition will be due or retained**.
- -Auto payments for tuition and costumes will be charged to your credit card on file and posted to your account the first week of the month.
- -If tuition is not received by the 10th of the month, a **\$15.00** late fee will be charged to your account. Tuition payments 30 days past due will result in the student's suspension from classes and performances.
- -Returned check fee is \$25.00.
- -Tuition is non-refundable after the 1st day of class. Exceptions will be made for serious injury or illness. A written notice of withdrawal and a doctor's note is required.
- -No reimbursement or credits will be made to your account for missed classes. A student may attend another class in their level or a level lower than their level as a make-up class. **Students cannot make-up a class in a higher level than their level**. There will be no exceptions.
- -Costume Fees are \$100.00 plus tax per performing class, per student. Costume Fees will be charged to your account in 2 installments, on October 1st and November 1st. There will be no refunds for costumes after December 1st. No Exceptions.
